#### **NEW BUSINESS**

The Possible shut down of Green Bank for conference due to COVID19 virus.

We had a brief discussion about the canceled Western Conference proceedings. (DW) and (DF) will coordinate making these proceedings available to SARA members.

Richard Russel (RR) is coordinating the August 2, 2020 Eastern Conference and has had extensive experience teaching college classes via teleconferencing.

On line would allow international participation both as attendees and presenters.

Possible web hosts are WebEx, Blackboard, or BlueJeans.

We already have BlueJeans for BOD meeting use at \$120/yr.

These all have a limited number of participants . Allowing more participants cost more. Typical limits are 50, 100, or 150.

(RR) will not be able to attend at Green Bank and will use video conference to coordinate and participate.

The Hi Tech Tour cannot be done by video conference because the video equipment is not allowed in the telescope area and Green Bank security restricts video and photos in their labs.

Will video conference be for members only or for a paid conference fee? See Appendix B.

A video conference participant can ask questions.

Streaming video allows no participation. Watch delayed program.

**Important:** Presentations via video conferencing MUST be on time just like in person presenters.

Do we have a printed proceedings for Green Bank? Do video participants get emailed files or mailed a thumb drive? (RR) and (DF) to address.

For printed, files can be emailed to Staples for printing on reasonable turn around.

#### Appendix A.

Comments on possible video conference problem send by Charles Osborne in an email after phone meeting:

One thing I didn't get a chance to comment on is that the bane of two way teleconferences is background noise from all the inbound lines. People breathing or coughing, dogs barking, fan noise, family coming into room talking, moving microphone clicks. People can and should mute unless they really want to be ready to ask a question. But some don't know how or forget. Even on our Board meetings we've had those issues frequently.

Blue Jeans seems to VOX and mute unless a person is talking and grabs the emphasis. They then even show whose phone number the inbound audio is coming from. So it is less mixing and more auto-switching somehow. But if someone is online with a lot of noise that may take over even from the presenter.

Also would be good to have a way for audience questions to be submitted via chat. I think it has that mode. I just didn't see it in same way as some video presentations I've been on.

Comments on possible video conference problem s sent by Jon Wallace in an email after the phone meeting:

Looks good but I think we also mentioned that the 'live' or 'online-interactive' conference would be for members only (the link sent by Dennis or whomever as mentioned later in your summary). I had also mentioned a small fee (\$10-20) to assure that people would 'show up' for the 'interactive online experience' - I have found that without a fee, people will sign-up and then sometimes 'blow it off' because it is free - nothing to lose - paying always improved participation. I also mentioned that I thought it might be good to have a sign-up for the 'online-interactive' group to be sure someone attends each presentation if the conference is 'online only' - nothing worse than presenting to no one!

#### **NEW BUSINESS**

The Likely shut down of Green Bank Observatory (GBO) for the conference due to COVID19 virus is a problem.

Rich Russel has planned on a professional science speaker for the key note. Cost \$300 in budget so it his call, with no vote needed.

We now have 11 confirmed papers to present.

Rich will set up BlueJeans or Zoom as needed. Conference is on line even if there is a presence at GBO. This will allow for 100 attendees.

Conference is now Saturday, August 1, and Sunday afternoon, August 2, for 1-1/2 days.

We will try to make a call on GBO presence by June 2.

We will continue to plan for a physical presence at GBO if possible and add teleconference for on line. If GBO cancels, the conference will be done as an on line only event."

We need to handle the elections on line. Details are in works.

Dennis has 2 Krauss books as door prizes. There will be others.

Ed H said he will attend at GBO if it happens. Mask and 6 ft. spacing is OK. Breaks and lunch need to be scheduled even if only on line.

Keith P. noted that both Zoom and BluJeans have the ability to handle side chats between individuals. This could be good for Drake Lounge.

Ed H. prefers face to face with pencil and paper for discussions. The lounge discussions are a big part of the conference.

We had some discussion about travel to the conference. This may cause low turnout if GBO is open.

Tom Crowley pointed out that we do have a lot of conflicting information on Covid19 and the status of GBO. Dennis F. is working on answer from GBO.

### Possible GBO problems:

Do they handle meals OK on Weekend?

Is dorm room availability the same as during the week?

There may be no staff at GBO for tours of labs and telescopes.

GBO virtual tours would be a security problem for them. Remember they prescreen people for tours.

We are planning on another meeting June 1 if needed. We may know more about GBO then.

Tom Crowley is OK with Saturday and Sunday conference. This would leave online more convenient for those who can' make GBO.
